**Waiver/Release**

I acknowledge that running is an inherently dangerous sport and fully realize the dangers of participating in a running/walking event and fully assume the risks associated with such participation including by way of example, and not limitation, the following: the dangers of vehicles, other runners, and fixed or moving objects; the dangers arising from surface hazards, the releasees' own negligence, and weather conditions; and the possibility of physical injury, serious injury, mental trauma and death associated with athletic running.

I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being release, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault. I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person. I acknowledge that this accident waiver and release of liability form will be used by the event holder, sponsors, and organizers in events in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assign as follows:

- a) Waiver, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event. - b) Indemnify and hold harmless the entities or persons mentioned in the paragraph from any and all liabilities or claims made by other individuals or entities as a result of any actions during this event.

**RELEASE OF LIABILITY**
